  - 4. Sierra Garden Apt. Update: IRM representative Mike Richards
    - a. Management changes- America and Edher Sanchez, they have been resident managers with IRM for several years. SJCLT is a 51% partner with Bucky Fong and David Michaels to form SJC,LLC. Being an LLC- we let the managers handle any complaints.
    - b. Comments from Residents-as an LLC we do not get involved with management. KTS is the legal firm that IRM uses. IRM reports weekly with management. How do you communicate with residents- 10-1-11 residents will meet and greet new managers- hopefully this will encourage communication. They plan a yard sale next weekend. Have managers ask for SGA resident to be a laison with SJCLT and other residents.
    - c. Inspections- recommend Diana Hankins work with IRM management to assist SGA renters when they have inspection and repair issues. How to communicate with the residents.
    - d. Siding warranty and Repairs- a 50 year warranty
      There has been discoloration-<u>Hardy</u> colored it and product was sold to <u>Meeks</u>
      It was installed with warranty. Ron Dos Rees-contractor- wants to make it right. Paint in Spring 2012- cost of \$120,000.00
    - e. Residual Distribution to SJCLLC members- Supposedly no cash flow in last 6 years. \$53,000.00 in cash flow now. \$11,000.00 in reserves. Riley made comment about residents being subsidized, but need to have inspections.
